About EdTech Tulna: The rapidly growing Indian EdTech landscape has resulted in an overwhelming choice of EdTech solutions for decision-makers such as governments, schools, investors, parents, and teachers. In the absence of information about the quality of products in the market, adopters are compelled to make ad-hoc decisions based on little or no evidence of a product's effectiveness. Hence, there is an acute need today for credible and accepted standards on the quality of EdTech products to simplify the decision-making process in a systematic manner. EdTech Tulna is an EdTech evaluation index for quality of product design developed as a public good. Created with the objective of catalysing information-led decision-making by EdTech adopters and encouraging quality-aligned supply in the ecosystem, it is a one-of-a-kind initiative with wide applicability in the Indian and global context. Over the last two years, Tulna has been received positively by both the product ecosystem and institutional adopters like the state and central government bodies.
